Pablo R. Flores	Park and Recreation	\$ 20	Mr. Flores is a Groundskeeper in the Park Division. He suggested that an adjustable feature be added to power edger handles. This was done by the manufacturer. This was considered to be a significant safety improvement.
Robert V. Murphy	Park and Recreation	\$ 20	Mr. Murphy is a Gardener in the Park Division. He suggested that office plant maintenance be curtailed. This was considered to be a significant operational improvement.
Charles E. Woolever	Financial Management	\$ 20	Mr. Woolever was an Associate Administrative Analyst at the time of his suggestion. He suggested that Form PC-3 be revised to include more information. This was considered to be a significant operational improvement.
Dennis P. Isom	Fire	\$ 20	Mr. Isom is a Firefighter. He suggested that signal buzzers be included on all specifications for new Fire Department vehicles. This was considered to be a significant safety improvement.
Dennis M. Grady	Personnel	\$ 20	Mr. Grady is an Associate Personnel Analyst. He suggested that an in service light be installed in the copy machine room. This was considered to be a significant operational improvement.
