Michael A. Gomez	Risk Management	\$ 20	Mr. Gomez is a Claims Representative II. He suggested that a postcard be used to contact claimants. This is expected to save \$110 annually in mail costs.
Stephen J. Linges	Fire	\$ 20	Mr. Linges is a Firefighter. He suggested that the driveway at Fire Station 12 be modified to prevent backing hazards. This was considered to be a significant safety improvement.
Phillip J. Love	General Services	\$ 20	Mr. Love was a Carpenter Supervisor in the Buildings Division. He suggested that traffic control signs be installed at the Starlight Bowl. This was considered to be a significant safety improvement.
Michael B. Strang	Fire	\$ 20	Mr. Strang is a Firefighter. He suggested that covers be installed on intake valve switches. This was considered to be a significant safety improvement.
Richard D. Leake	Fire	\$ 20	Mr. Leake is a Captain. He suggested that pockets be added to brush jackets to carry radios. This was considered to be a significant safety improvement.
