| Silas Puentas | Utilities | \$ 20 | Mr. Puentas is a Utility Supervisor in the Quality Division. He suggested that additional directional signs to the Wild Animal Park be posted. This was considered to be a significant public service improvement. |
| John M. Whyte | Fire | \$ 20 | Mr. Whyte is a Captain. He suggested that the Fire Department purchase a less expensive stethoscope. Savings are expected to be significant. This is a partial award pending a final 12-month review. |
| Donna J. Damson | Mayor's Office | \$ 10 | Ms. Damson suggested that that the Certificates of Merit used in the Suggestion Awards Program be updated. This was considered to be a significant operational improvement. |
