BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

Said Council hereby finds that that certain map surveyed
by CHARLES W. CHRISTENSEN, a Registered Civil Engineer, entitled
"POINT LOMA GARDEN VILLAS Being a subdivision of Lots 1 and
2 of Westlawn according to Map thereof No. 1464 filed in the
office of the County Recorder of San Diego County July 17, 1912,
and a portion of Pueblo Lot 239 of the Pueblo Lands according
to Map hereeof made by James Pascoe in 1870, a copy of which
was filed in the office of the County Recorder of San Diego
County November 14, 1921, and is known as Miscellaneous Map
No. 36, and Superior Court Case 51015, together with portions
of Greenwood Street and Davis Street as closed and vacated to
public use, all in the City of San Diego, County of San Diego,
State of California.," is made in the manner and form
prescribed by law and conforms to the surrounding surveys;
that said map and the subdivision of land shown thereon is
hereby approved and accepted.


The Clerk of said City is hereby authorized and directed
