BE IT RESOLVED, by the Council of The City of San Diego as follows:


That the City Auditor and Comptroller be, and he is hereby authorized to transfer the sum of \$2,700 from C.I.P. Project #90-245 Unallocated Reserve to C.I.P. Project #200-01 Minor Improvements.

BE IT FURTHER RESOLVED, that the expenditure of \$2,700 from C.I.P. Project #20-001, of The City of San Diego, be hereby authorized, solely and exclusively, for the installation of a water service and a hose bib irrigation system for La Jolla Hermosa Park.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized and empowered to use City forces for furnishing and installing a water service, meter and hose bib irrigation system for La Jolla Hermosa Park, in the City of San Diego, California, pursuant to recommendation of the City Manager and submission of estimates by him indicating that said work can be done by City forces more economically than if let by contract; at a cost not to exceed \$2,700.
