That the Department of Legislative Representation is hereby directed to take all necessary action, for and on behalf of The City of San Diego, to seek new legislation which would require bicycle retailers to act as bicycle licensing agents for Cities and Counties which license bicycles and also to increase the three (3) year bicycle license and renewal fee to \$3.00 upon the effective date of the new legislation.
