WHEREAS, by Resolution No. 223849, adopted by the Council of The City of San Diego on July 2, 1979, the low bid of of GUARDIAN MAINTENANCE INCORPORATED for furnishing janitorial services at the Central Library was accepted; and

WHEREAS, subsequent to July 2, 1979, Guardian Maintenance Incorporated failed to perform the contract in accordance with the specifications and failed to correct deficiencies which had been called to their attention; and


WHEREAS, notification was given to Guardian Maintenance Incorporated that they would be declared in default of their contract with the City if the deficiencies were not corrected by December 31, 1979; and

WHEREAS, said deficiencies have not been corrected; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that GUARDIAN MAINTENANCE INCORPORATED is hereby declared to be in default on their contract for furnishing Janitorial Services at the Central Library.
