

RESOLUTION NO. R- 251135

WHEREAS, the American Youth Hostels (herein called Hostels) is planning a bicycle tour through the cities surrounding San Diego Bay on Sunday, February 24, 1980; and

WHEREAS, this "GRAND BICYCLE TOUR OF FIVE CITIES" is part of Hostels' program in support of the national effort to advance energy-conservation forms of transportation; and

WHEREAS, it is Hostels' intention to increase interest in use of the bicycle as a healthful commuter and recreation vehicle; and

WHEREAS, in order to accomplish this objective, a thousand bicyclists will be escorted on a carefully organized and supervised tour around the Bay, utilizing existing and proposed bicycle routes in the cities of San Diego, Coronado, Imperial Beach, Chula Vista and National City; and

WHEREAS, integral to the success of this community event is the rare opportunity to cross the San Diego-Coronado bridge on bicycle; and

WHEREAS, to carry out procedures for a bridge crossing permit, the California Department of Transportation requires a resolution from municipalities on both ends of the bridge; and

WHEREAS, the City of Coronado has given assurances of support to this endeavor; and

WHEREAS, it is now necessary and requested by the San Diego Council of American Youth Hostels that the City of San Diego pass a resolution acknowledging suspension of east-bound traffic on the bridge and approving the event on February 24, 1980, between the hours of 8:30 a.m. and 11:00 a.m.; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the American Youth Hostels is hereby commended for its sponsorship of the "GRAND BICYCLE TOUR OF FIVE CITIES" as part of a program to advance energy conserving forms of transportation.

BE IT FURTHER RESOLVED, that this Council hereby declares that The City of San Diego, in conjunction with and furtherance of the program, has no objection to the suspension of east-bound traffic on the San Diego-Coronado Bridge on Sunday, February 24, 1980, between the hours of 8:30 a.m. and 11:00 a.m.
