VACATION OF A PORTION OF STATE STREET ADJACENT  
TO LOTS 5, 6 AND 7 OF BLOCK 95 OF MIDDLETOWN TRACT.

WHEREAS, it is proposed that a PORTION OF STATE STREET  
ADJACENT TO LOTS 5, 6 AND 7 OF BLOCK 95 OF MIDDLETOWN TRACT  
be vacated; and

WHEREAS, there is no present or prospective use for  
the street either for the public street system for which  
the right-of-way was originally acquired or for any other  
public use of a like nature that can be anticipated; and

WHEREAS, the public will benefit from the vacation  
through improved utilization of land; and

WHEREAS, the vacation or abandonment is not incon-  
sistent with the General Plan or an approved Community Plan;  
and

WHEREAS, the public street system for which the right-  
of-way was originally acquired will not be detrimentally  
affected by this vacation; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego,  
California, that the PORTION OF STATE STREET ADJACENT TO  
LOTS 5, 6 AND 7 OF BLOCK 95 OF MIDDLETOWN TRACT, as more  
particularly referred to in Resolution of Intention No.


R- 250930, is unnecessary for present

as more particularly shown on Drawing No. 14737-B on file

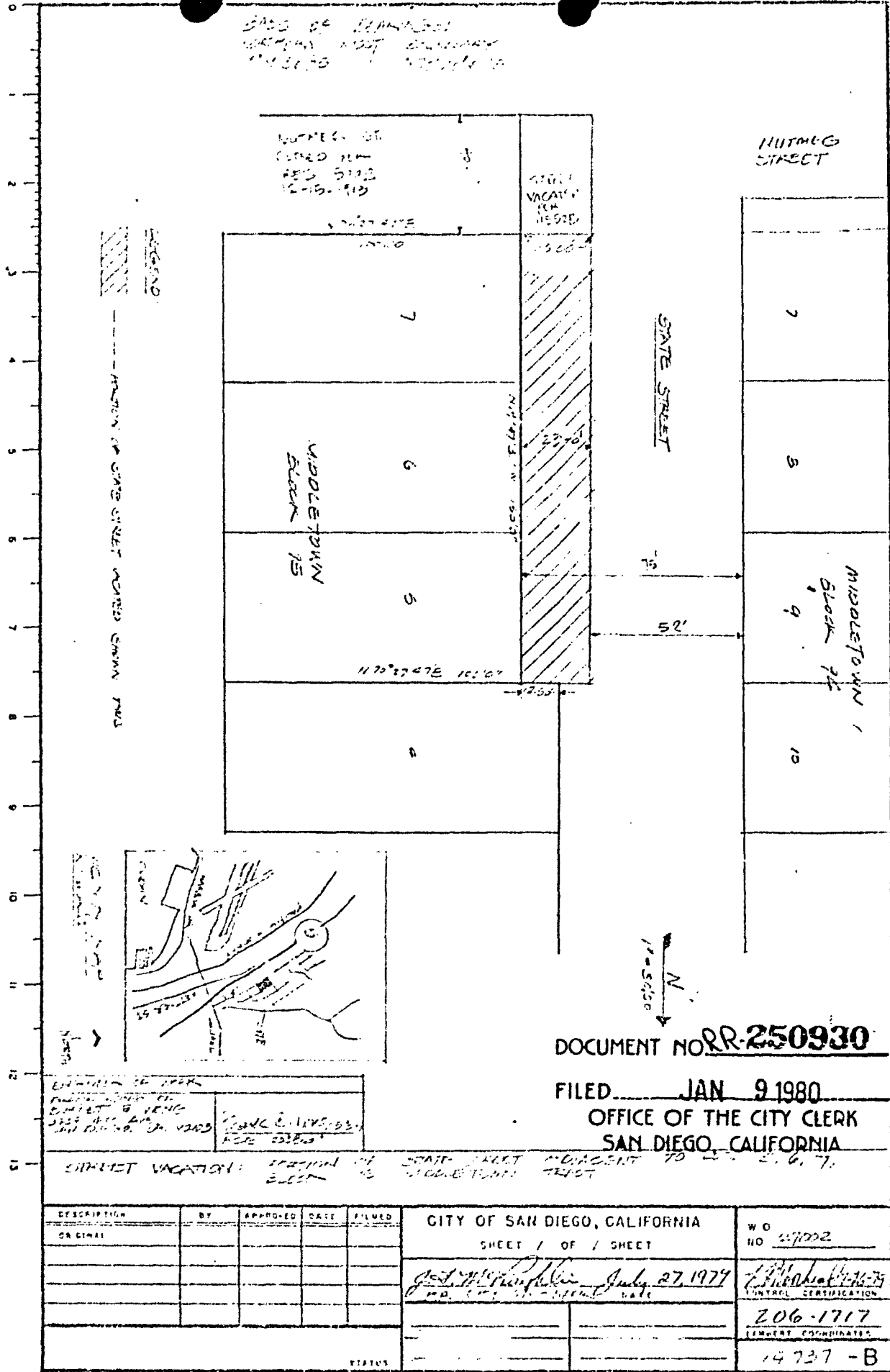
in the office of the City Clerk as Document No. RR-250930,

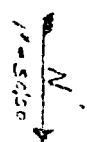
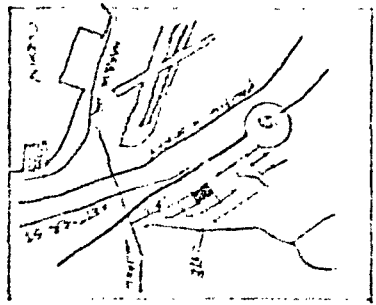
