


RESOLUTION No. RR-251146 (R-80-1328)

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, a five-year Use and Occupancy Permit with the STATE OF CALIFORNIA (California Highway Patrol) for operation and maintenance of radio transmitting and receiving equipment at Mt. Woodson, at a rental rate of \$750 per year for the five-year period, under the terms and conditions set forth in the Use and Occupancy Permit on file in the office of the City Clerk as Document No. RR- 251146.
