That the Mayor and City Clerk of said City be, and they are hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a grant deed, a copy of which is on file in the office of the City Clerk as Document No. 251153, granting to ALPHONSO CERISE, the adjacent property owner, all that portion of Lots 10, 11, 18 and 19 of Grantville and Out Lots, Map No. 776, as more particularly described in said deed.
- 3. That no broker's commission shall be paid by City on the herein described negotiated sale.
- 4. That the City Clerk is hereby authorized and directed to deliver said deed and a certified copy of this resolution to the Property Department for further handling.
