WHEREAS, the successful implementation of the Horton House Project requires Block Grant Funds in the estimated amount of \$1,385,000; and

WHEREAS, Block Grant Funding in the amount of \$1,085,000 was approved in 1977 and included in an approved Horton House Project Budget set forth in that document on file in the Office of the Secretary of the Redevelopment Agency as Document No. 508; and

WHEREAS, Block Grant Funding in the amount of \$1,385,000 is included in the approved amended Horton House Budget which is set forth in that document on file in the Office of the Secretary of the Redevelopment Agency as Document No. 614;

NOW, THEREFORE, BE IT RESOLVED, by the Council of the City of San Diego, as follows:


1. That the transfer of \$300,000 from 1980 Community Development Block Grant Contingency Funds 18516, Department 5962, Organization 7001 to Fund 18516, Department 5962, Organization 6204 for the Horton House Residential Project, is hereby authorized.

2. That the work program and budget for the Horton House Residential Project as set forth in that document on file in the Office of the City Clerk as Document No. R-251160 are hereby approved.

3. That the City Auditor is hereby authorized, for the purpose of completing the Horton House Project, to transfer the sum of \$300,000 from the 1980 Community Development Block Grant Fund No. 18516 to the Redevelopment Agency as an advance to be repaid from tax increment or other project revenues. Transfer of funds is contingent on the receipt and approval of the 1980 CDBG application.

In the event that the Agency desires to issue bonds, notes, or other instruments of indebtedness of the Agency to carry out the Marina or Columbia Redevelopment Projects, then the indebtedness of the Agency under this Resolution shall be deemed not to be a first pledge of tax increment allocations received by the Agency pursuant to Health and Safety Code, Section 33670; and the indebtedness of the Agency under this Resolution shall be subordinate to any pledge of tax increments to bondholders or the holders of other such instruments of indebtedness.
