

RESOLUTION NO. R-251162

(R. 80-1242)

WHEREAS, one United States household in every five has been hit by crime at least once in the last 12 months, with either property stolen or a member of the household becoming the victim of a physical assault, according to the findings of a Gallup poll released in December 1979; and

WHEREAS, the Gallup survey findings parallel the upturn in crimes reported by the Federal Bureau of Investigation which reported increases in every kind of major crime for the first six months of 1979; and

WHEREAS, the Bureau of Criminal Statistics of the California Department of Justice has documented similar results; and

WHEREAS, there has been insufficient public attention to the rights and plight of crime victims in our society and to effective crime prevention programs to reduce the numbers of crime victims; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that, in recognition of the foregoing and the mandate contained in article V, section 13, of the California Constitution, which proclaims the State Attorney General to be California's chief law officer, the Council hereby endorses and supports California Crime Watch and the Attorney General's Plan to Restore Public Safety in the 80's.
