- 3. That the reason said property is being sold by negotiation is to provide the purchaser with a relocation site as a result of the acquisition of said purchaser's property in the Dells Redevelopment Project.
- 4. That no broker's commission shall be paid by City on the herein-described negotiated sale.
- 5. That the City Clerk of said City is hereby authorized and directed to deliver said deed and a certified copy of this resolution to the Property Department for further handling.
