

RESOLUTION NO. R- 251167

WHEREAS, extended litigation (Del Mar v. City of San Diego) exists regarding the development of North City West; and

WHEREAS, that development is an integral part of San Diego's growth plan; and

WHEREAS, Robert H. Freilich and Associates were instrumental in the promulgation of said growth plan as planning consultants; and

WHEREAS, it is now desirable and necessary to employ them as planning consultants for the extended litigation; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That the City Attorney be and he is hereby authorized to execute an agreement with ROBERT H. FREILICH AND ASSOCIATES for consulting and legal services in an amount not to exceed \$15,000 in connection with the North City West litigation case DEL MAR v. CITY OF SAN DIEGO, Superior Court Case No. 444177, pursuant to the terms and conditions of that agreement on file in the office of the City Clerk as Document No. RR-251167, which agreement is promulgated pursuant to Section 2.A.4. of that certain agreement on file in the Office of the City Clerk as Document No. 766482 which, by this reference, is fully incorporated herein.

2. That the Auditor and Comptroller be and he is hereby authorized to transfer within the General Fund 100 the sum of \$15,000 from the Unallocated Reserve (605) to the Allocated Reserve (901) to be used solely and exclusively for the above purpose.







CERTIFICATION OF UNENCUMBERED BALANCE


