

RESOLUTION NO. R-251168

(R. 80-1489)

WHEREAS, the Council of The City of San Diego, by Resolution No. 250257, dated September 18, 1979, expressed its concern regarding adequate flood protection along Las Chollas Creek; and

WHEREAS, the flood dangers expressed at that time encompassed various geographic areas and all persons and property included therein; and

WHEREAS, recent severe storms have once again caused flood situations which have caused loss of life and, in general, created a hazardous condition; and

WHEREAS, such situation is of major import and requires immediate attention and legislative action; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby directed to investigate improved and unimproved flood control systems in areas that were subdivided at a time when appropriate flood control measures were not required and, in which predominantly residential development has occurred or is occurring to determine (1) what further measures, if any may be required to protect persons and property from flood damage, and (2) what actions may be taken by modification in design or installation of barriers to reduce or eliminate hazards attractive to children, should they exist.

BE IT FURTHER RESOLVED, that the City Manager is hereby directed to report to the Council on progress made in implementing the directives contained in Resolution No. R-250257, adopted by Council on September 18, 1979.
