

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Attorney or his representative is hereby authorized to travel to New York, N.Y., on or about February 27, 1980, for the purpose of affecting delivery of necessary instruments and participating, on behalf of the City, in the sale of The City of San Diego Hospital Revenue Bonds (Mercy Hospital and Medical Center, San Diego) Series A, in the amount of \$29,000,000. The cost of travel and any expenses incident thereto shall be reimbursed by Mercy Hospital pursuant to agreement approved concurrently with this resolution and that agreement approved by Resolution No. 250519 adopted October 29, 1979.
