BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer \$1,000.00 from CIP 90-220 "Gas Tax Fund Reserve" to CIP 62-141 "Beryl St. and Soledad Mountain Road."

BE IT FURTHER RESOLVED, that the expenditure, not to exceed \$50,000.00 from Gas Tax Fund 220 and Capital Outlay Fund 245 of the City of San Diego is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
