

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager be and he is hereby authorized and empowered to do by City Forces all necessary work in conjunction with electrical work on E Street and Third Avenue to convert the street lighting and traffic signal systems in the Center City Development Corporation demolition area in conjunction with the new underground electrical systems being installed by San Diego Gas & Electric Company, pursuant to the recommendation of the City Manager and the submission of his estimates indicating that said work can be done more economically by City Forces than if let by contract.

BE IT FURTHER RESOLVED, that the expenditure of \$24,300 is hereby authorized from Capital Outlay Funds CIP 37-028, "Undergrounding of City Utilities," solely and exclusively for the above project.
