


RESOLUTION No. A-251225 (R-80-1308)

BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the bid of \$616,590.00 by WESTERN PACIFIC DREDGING COMPANY, DIVISION OF RIEDEL INTERNATIONAL, INC., a corporation for CONSTRUCTION OF ROSE CREEK INLET RESTORATION in the City of San Diego, California is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. A-00025.
2. That the City Auditor and Comptroller is hereby authorized to transfer from Capital Outlay Fund 30245 to CIP No. 13-003 Mission Bay Shore Protection Fund the following: \$90,000.00 of CIP 22-808 Fiesta Island Development; \$45,914.00 of CIP 21-001 Balboa Park Signs and Information; \$108,000.00 of Montgomery-Waller Neighborhood Park No. 5 Fund 29-248; \$55,536.00 of CIP 90-245 Unallocated Reserve; \$12,000.00 of CIP 23-820 Lake San Vicente Parking Lot.
3. That the expenditure of \$311,456.00 is hereby authorized out of Capital Outlay Fund 30245 of the City of San Diego solely and exclusively for providing funds for said project and related costs.
