BE IT RESOLVED, by the Council of The City of San Diego as follows:


That the City Manager is hereby authorized and empowered to accept the Grant Deed of SAN DIEGO UNIFIED SCHOOL DISTRICT OF SAN DIEGO COUNTY, CALIFORNIA, executed in favor of The City of San Diego, bearing date of January 24, 1980, conveying to said City Lot 390 of Princess Gardens Unit No. 7, as more particularly described in said deed.

BE IT FURTHER RESOLVED, that the expenditure of \$107,500 from CIP 52-273 for the acquisition of said property and related expenses is hereby authorized and approved.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized and directed to proceed with all steps necessary to accomplish the subdivision of said property so that approximately 3.2 acres of the 7.21 acres acquired pursuant to this resolution may be sold at public auction.

BE IT FURTHER RESOLVED, that the Mayor is hereby authorized and empowered to sign, on behalf of the City, the parcel map in connection with such subdivision.
