BE IT RESOLVED, by the Council of The City of San Diego as follows:


That the low bids of 1. HACIENDA LANDSCAPE COMPANY, and  
2. ENVIRONMENTAL CARE, INC., are hereby accepted; and the  
City Manager is hereby authorized to execute contracts for  
furnishing COMPLETE LANDSCAPE MAINTENANCE OF FOURTEEN (14)  
SELECTED CITY SITES as may be required for the period beginning  
March 1, 1980 through January 31, 1981 with an option to renew  
for two (2) additional one (1) year periods as follows:

1. HACIENDA LANDSCAPE COMPANY for sites 2, 4, 13 and  
14 per prices on file in the Purchasing Department;  
terms net 30 days.
2. ENVIRONMENTAL CARE, INC., for sites 1, 3, 5, 6, 7, 8,  
9, 10, 11 and 12 per prices on file in the Purchasing  
Department; terms 2% 20 days.

BE IT FURTHER RESOLVED, that the City Manager is hereby  
authorized to enter into landscape maintenance agreement prior  
to June 30, 1980 for five of the 14 park sites which are park  
sites not heretofore previously authorized for contractual  
landscape maintenance services.
