

BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the bid of DAVE MARTIN SUPPLIES & TRUCKING INC. is hereby accepted and the City Manager is hereby authorized to execute a contract for REMOVAL AND DISPOSAL OF APPROXIMATELY 30,000 - 40,000 CUBIC YARDS OF DRIED SLUDGE AT FIESTA ISLAND as may be required at a cost of \$2.50 per cu. yard; terms net 10 days.
2. That the City Auditor and Comptroller is hereby authorized to transfer \$100,000.00 within Sewer Revenue Fund (41506) from the Unallocated Reserve (70697) to Point Loma Treatment Operation Fund (70225) for this purpose and related costs.
