


RESOLUTION No. R-251244 (R. 80-1309)

BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the bid of FMC CORPORATION, ENVIRONMENTAL EQUIPMENT DIVISION is hereby accepted and the City Manager is hereby authorized to execute a contract for the purchase of TWO (2) EACH MECHANICALLY CLEANED BARSCREENS at a cost of \$40,220.50 each for a total cost of \$80,441.00; terms net 10 days plus sales tax plus an estimated freight charge of \$2,734.00.
2. That the City Auditor and Comptroller is hereby authorized to transfer \$88,001.46 within Sewer Revenue Fund (41506) from the Unallocated Reserve to Metropolitan Pump Station No. One Maintenance (70233), for this purpose and related costs.
