

RESOLUTION NO. R-251255 (R.80-1391)

WHEREAS, certain public utilities and sewer easements were acquired for an earlier development known as Paradise Hills Unit No.3; and

WHEREAS, the property where the easements exist is being re-subdivided by a subdivision known as Reo Terrace; and

WHEREAS, the aforementioned easements have never been used for the purpose for which they were acquired; and

WHEREAS, the present easement alignments will conflict with the proposed development within Reo Terrace; and


WHEREAS, the City has no present or prospective use for said easements and the City Manager has recommended that the City abandon its interests therein; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

1. That The City of San Diego, by this resolution, does hereby abandon whatever right, title or interest it may have in the public utilities and sewer easements, as more particularly shown on Drawing No. 14689 on file in the office of the City Clerk as Document No. RR-251255-1, which is by this reference incorporated herein and made a part hereof.

2. That the City Clerk shall cause a certified copy of this resolution attested by him under seal, to be recorded in the office of the County Recorder.
