BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

Said Council hereby finds that that certain map surveyed
by LEO H. BARBOUR, a Registered Civil Engineer, entitled
"WESTWOOD UNIT NO. 16 Being a subdivision of a portion of
Rancho San Bernardo, in the City of San Diego, County of
San Diego, State of California, according to Map thereof
filed in the office of the County Recorder of San Diego County,
in Book 2, Page 462 of Patents, records of said County.," is
made in the manner and form prescribed by law and conforms to
the surrounding surveys; that said map and the subdivision of
land shown thereon is hereby approved and accepted; and said
Council hereby accepts on behalf of the public, the following:
Aguacate Way, Alborada Drive, Creciente Way and Creciente
Court for public purposes; and said streets are hereby
declared to be public streets and dedicated to the public
use.


The Clerk of said City is hereby authorized and directed
