WHEREAS, the Suggestion Awards Committee has heretofore made certain recommendations to this Council; and

WHEREAS, the Council has reviewed said recommendations as well as the suggestions as presented; NOW THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

That the following suggestion awards are hereby approved and the Auditor and Comptroller is hereby directed to issue warrants out of the General Fund for the following suggestions:

<u>NAME</u>	<u>DEPARTMENT</u>	<u>AMOUNT</u>	<u>SUGGESTION</u>
Eldon D. Smith	Police	\$ 290	Mr. Smith is a Police Sergeant. He suggested a simplified procedure for voiding and/or dismissing citations. This reduces the number of levels of review and saves an estimated \$5,835 annually. This is a partial award pending a final 12-month review.
Nicholas E. Haluskey	Building Inspection	\$ 150	Mr. Haluskey is a Senior Building Inspection Inspector. He suggested that field inspection forms IN-869 and IN-870 be combined to reduce paperwork. Estimated annual savings are \$3,079. This is a partial award pending a final 12-month review.
Vincent DeLeva	General Services	\$ 110	Mr. DeLeva was an Electrician at the time of his suggestion. He suggested that defective mercury vapor street light luminaries be replaced with high pressure sodium types. This saves an estimated \$2,196 annually in energy costs. This is a partial award pending a final 12-month review.
James E. Foley	Engineering & Development	\$ 100	Mr. Foley is the supervisor of the Transportation Design administrative section. He suggested that "blue dot" raised reflectors be installed in streets to mark fire hydrant locations. This is currently being accomplished by developers as part of street specifications. This was considered to be a significant public safety improvement.
