

RESOLUTION NO. R- 251278Adopted on FEB 25 1980

WHEREAS, the Suggestion Awards Committee has heretofore made certain recommendations to this Council; and

WHEREAS, the Council has reviewed said recommendations as well as the suggestions as presented; NOW THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

That the following suggestion awards are hereby approved and the Auditor and Comptroller is hereby directed to issue warrants out of the General Fund for the following suggestions:

<u>NAME</u>	<u>DEPARTMENT</u>	<u>AMOUNT</u>	<u>SUGGESTION</u>
John R. Fowler	General Services	\$ 20	Mr. Fowler was a Custodian II at the time of his suggestion. He suggested that two-way reflectors be placed on the Montgomery Field runway 28R. Although this was not done, reflective tape was placed on existing runway light fixtures. This was considered to be a significant safety improvement.
David A. Ytreus	Fire	\$ 20	Mr. Ytreus is a Firefighter. He suggested that the pump control panel on Apparatus 1355 be covered with a non-reflective material. This was considered to be a significant safety improvement.
David R. Warfield	Fire	\$ 10	Mr. Warfield is a Fire Captain. One year ago he earned a partial award of \$15 for his suggestion to provide only the Summary of Current Examinations to Fire Stations. Total first year's savings were \$250. This is the remainder of his award.
Dennis M. Grady	Personnel	\$ 10	Mr. Grady is an Associate Personnel Analyst. One year ago he earned a \$10 award for his suggestion to use classified advertising in local papers without utilizing the advertising service. Total first year's savings were \$151. This is the remainder of his award.
Walter J. Borden	Property	\$ 10	Mr. Borden is a Community Development Specialist III. He suggested that a container be provided at the Cashier's Window in COB for depositing water bills. Although savings are impossible to calculate, this should provide better service to the public and reduce waiting lines.
