- 1. That the City Manager be, and he is hereby authorized and empowered to do by City Forces all required work for storm damage repairs.
- 2. That the City Manager is hereby directed to take all necessary steps to insure that restoration of damaged City facilities will be eligible for Federal assistance.
- 3. That the City Manager is hereby authorized to take all appropriate steps, including execution of Inter-Agency agreements, to assure that storm damage repairs in jurisdictional boundary areas are carried out in the most expeditious manner.
- 4. That the City Manager is hereby designated as the City's authorized agent for the purpose of receipt, processing and coordination of all requirements necessary to obtain Federal assistance.
- 5. That the City Manager is hereby authorized and empowered to execute, for and on behalf of said City, supplements to existing professional service agreements with three (3) consultant firms at an estimated total cost not to exceed \$200,000.
- 6. That the expenditure not to exceed \$200,000 is hereby authorized from the Gas Tax Unallocated Reserve Fund for the above purpose.

- 7. That the Purchasing Agent is hereby authorized to advertise for bids without prior Council approval of plans and specification.
- 8. That the City Manager is hereby authorized to enter into a contract for emergency supplies and/or services, provided no single contract shall exceed \$25,000.
