BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the low acceptable bid of UNION OIL COMPANY OF CALIFORNIA is hereby accepted; and the City Manager is hereby authorized to execute a contract for the purchase of LUBRICATING OILS AND GREASES as may be required for the period of one (1) year beginning March 1, 1980 through February 28, 1981, per prices on file in the Purchasing Department; with a price escalation not to exceed 30% of bid prices with an option to renew contract for an additional one (1) year period from March 1, 1981 through February 28, 1982, with a price escalation not to exceed 30% of prices of the initial contract year.
