


RESOLUTION No. R- 251303 (R80-1339)

That the City Manager is hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a Lease Agreement with B.R. and B.J. JONES, dba FLYING "J" AVIATION, for a term of 2 years, of certain property at Brown Field Airport, more particularly described as Parcel A on the attachment hereto, for the purpose of a fixed base aircraft operation with rental based on percentages of gross income against a minimum annual rent of \$9,800, under the terms and conditions of that form lease on file in the office of the City Clerk as Document No. RR-251303 .

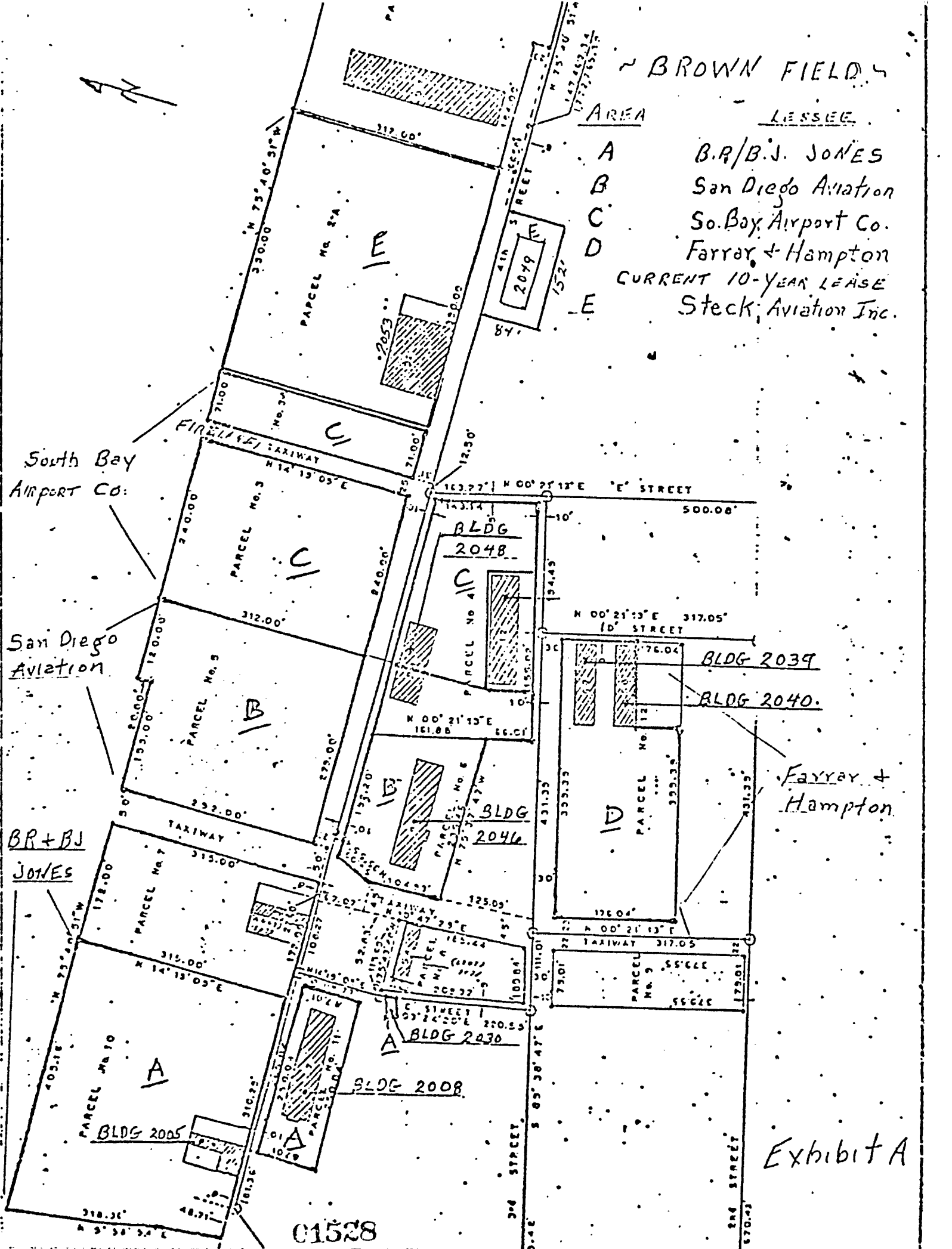
