That the City Manager is hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a Lease Agreement with SAN DIEGO AVIATION, INC., for a term of two (2) years, of certain property at Brown Field Airport, more particularly described as Parcel B on the attachment hereto, for the purpose of a fixed base aircraft operation with rental based on percentages of gross income against a minimum annual rent of \$7,500, under the terms and conditions of that form lease on file in the office of the City Clerk as Document No. RR-251304.

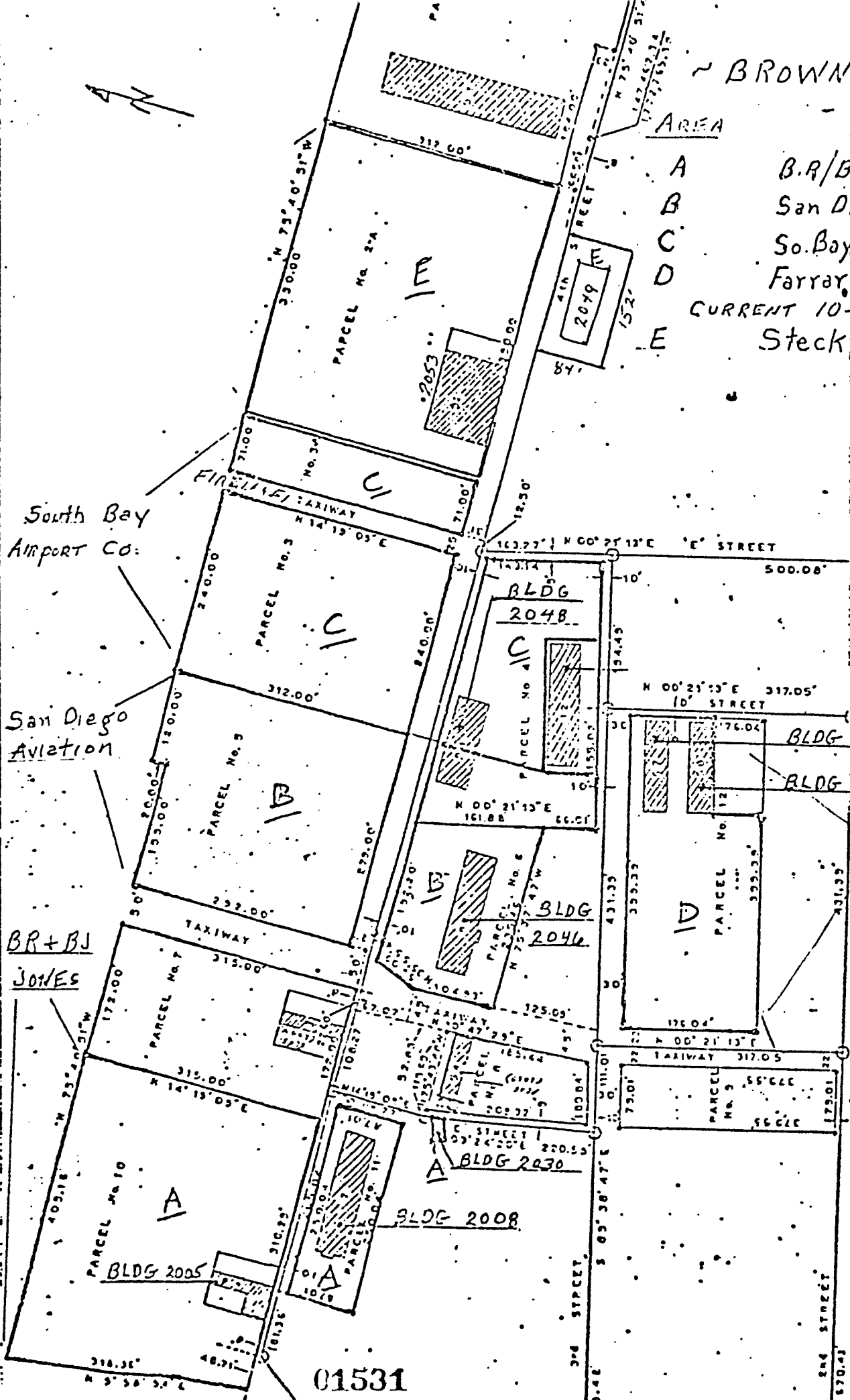
