


RESOLUTION No. R-251306 (R80-1342)

That the City Manager is hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a Lease Agreement with FARRAR & HAMPTON, dba MUSTANG AVIATION ENTERPRISES, for a term of two (2) years, of certain property at Brown Field Airport, more particularly described as Parcel D on the attachment hereto, for the purpose of a fixed base aircraft operation with rental based on percentages of gross income against a minimum annual rent of \$9,140, under the terms and conditions of that form lease on file in the office of the City Clerk as Document No. RR-251306.

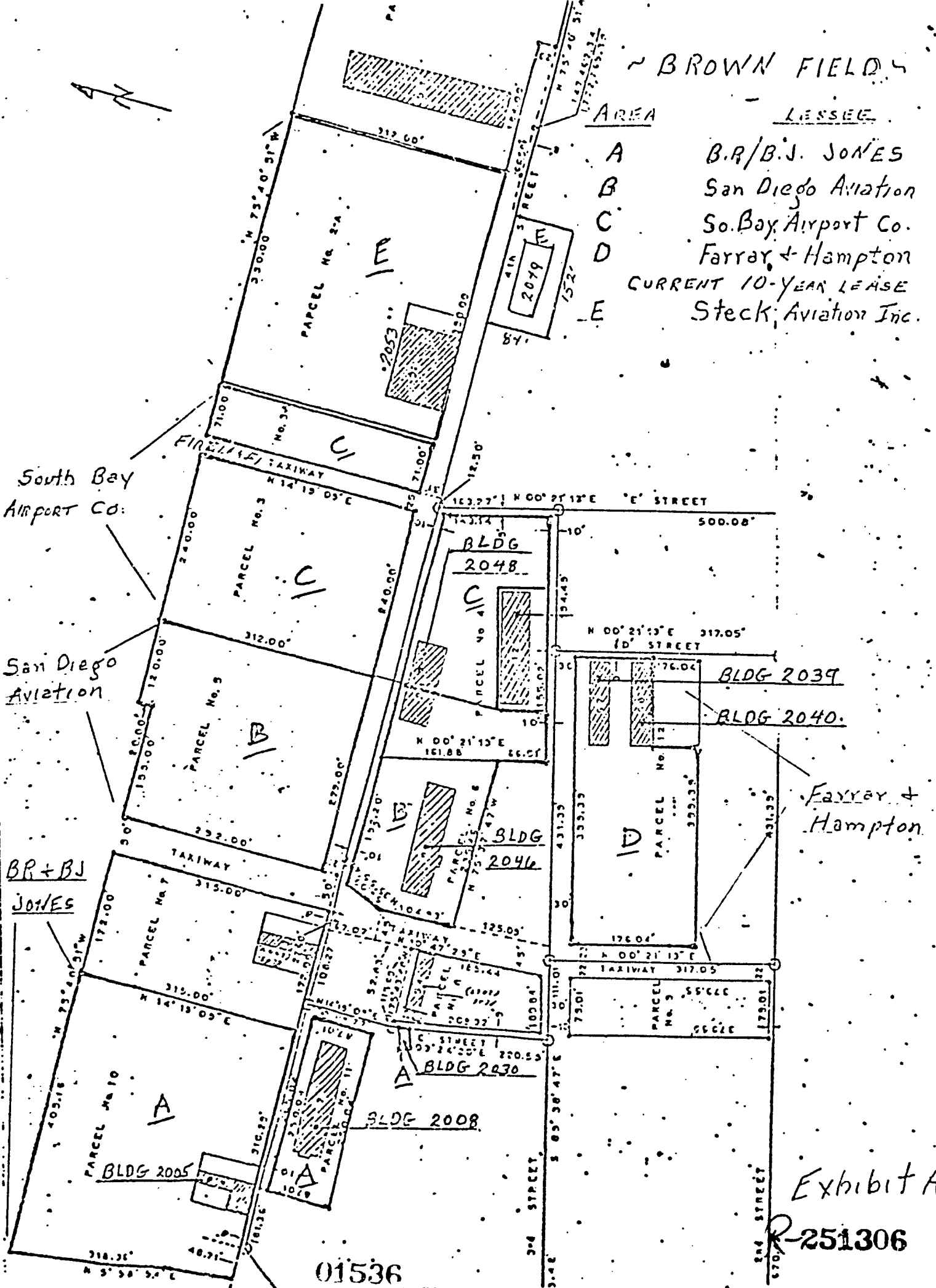
