WHEREAS, The City of San Diego is the owner of a portion of Lot 15, Block 87 of Choates Addition; and

WHEREAS, The City desires to negotiate the sale of said land to CEDAR RIDGE LIMITED, a California Limited Partnership, under the provisions of Section 22.0902 of the San Diego Municipal Code, which permit the sale of real property belonging to The City of San Diego by negotiation; and

WHEREAS, the sale of such real property as this may reasonably be accomplished by negotiation; and

WHEREAS, the value of the property to be conveyed by the City is the sum of ONE THOUSAND FIVE HUNDRED AND FIFTY DOLLARS (\$1,550); and

WHEREAS, no real estate broker's commission shall be paid; and

WHEREAS, the sale of the aforementioned property right is consistent with the public interest; NOW, THEREFORE,

- 3. That no broker's commission shall be paid by City on the herein-described negotiated sale.
- 4. That the City Clerk is hereby authorized and directed to deliver said deed and a certified copy of this resolution to the Property Department for further handling.
