WHEREAS, the Board is established as a policy advisory board to the City Council on matters relating to the acquisition, development, maintenance and operation of parks, beaches and recreation property and facilities; and

WHEREAS, the Board is also responsible for providing advice relative to the maintenance of the San Diego La Jolla Underwater Park as a marine life preserve; and

WHEREAS, the scope of the Board's responsibility is exceptional when viewed in the context of San Diego's concern for maintenance of a high environmental quality of life; and

WHEREAS, the magnitude of the Board's activity is further called forth by the concern of citizens for the protection and growth of park lands and recreation areas and facilities within San Diego; and

WHEREAS, the members of the Board devote many hours performing this very vital public service on a volunteer basis, taking such time away from otherwise busy schedules; and

WHEREAS, such devotion to public duty is rewarded only in the knowledge that each member's contribution shall be for the benefit of generations to come; and

WHEREAS, James S. Milch has served as chairman of the Board for the past eight years; and
