WHEREAS, pursuant to Public Resources Code, Section 5026, the State Historical Resources Commission is required to solicit comments of local city councils and boards of supervisors on applications for placement on the National Register of Historic Places; and

WHEREAS, the City of San Diego Historical Site Board, at its January 11, 1980 meeting, has reviewed and considered the National Register of Historic Places Applications for the GRAND-HORTON HOTEL, the ROBERT E. LEE HOTEL/LYCEUM THEATER and the KNICKERBOCKER HOTEL; and

WHEREAS, the Historical Site Board has submitted its advisory opinion to the State Historical Resources Commission and has requested the concurrence of the City Council in its endorsement of the GRAND-HORTON HOTEL and the ROBERT E. LEE HOTEL/LYCEUM THEATER for placement on the National Register of Historic Places; NOW, THEREFORE,
