
WHEREAS, the recent rains, weather disturbances and subsequent flooding have caused substantial and severe damage to some residential, commercial and agricultural properties; and

WHEREAS, in some cases the relocation of individuals, families and business enterprises has become necessary due to said flooding; and

WHEREAS, these relocations may, on certain occasions, raise questions of compliance with all of the provisions of the Municipal Code to the end that strict compliance may preclude relocation in certain cases thereby adding to the difficulties and distress already endured by individuals, families and business enterprises; NOW, THEREFORE,

BE IT RESOLVED, that the City Manager and Planning Director be and they are hereby urged and requested to review any and all situations requiring relocation as aforesaid which come to their attention and through their respective offices provide any and all persons similarly affected with such permission and allowance to relocate as may be possible under the circumstances provided, however, that in no event shall any temporary or permanent relocation be allowed or permitted that would clearly endanger the public health, welfare or safety of any individual affected thereby.
