1. That the low bid of \$37,992.00 by AUTOMATIC SPRINKLERS OF THE PACIFIC, INC., a corporation, for the CONSTRUCTION OF THE BALBOA PARK BUILDINGS-CODE UPGRADING-INSTALLATION OF AUTOMATIC FIRE SPRINKLER SYSTEMS IN THE STARLIGHT BOWL in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the Office of the City Clerk as Document No. A-00022.
2. That the City Auditor and Comptroller is hereby authorized to transfer \$8,000.00 from CIP 21-351 Mall-Organ-Palm Canyon Area-Japanese Garden to CIP 21-109 within the Park and Recreation Bond Fund 30725.
3. That the expenditure, not to exceed, \$8,000.00 from CIP 21-109, Park and Recreation Bond Fund 30725 of the City of San Diego is hereby authorized solely and exclusively for providing funds for said project and related costs.
