That the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, Utilities Agreement No. 24648 and Utilities Agreement No. 24648-A with the STATE DEPARTMENT OF TRANSPORTATION for sewer main relocations on Interstate 15 between 0.4 miles south and 0.7 mile north of Route 274 (Balboa Avenue), under the terms and conditions set forth in the agreements on file in the office of the City Clerk as Documents No. RL-251340-1 and No. RL- 251340 - 2 .

BE IT FURTHER RESOLVED, that the expenditure, not to exceed \$34,518 is hereby authorized from Sewer Revenue Fund 41506 (CIP No. 43-004), solely and exclusively for the purpose of providing funds for the sewer main relocations.
