


RESOLUTION No. R-251343 (R80-1435)

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, a First Amendment to Agreement with the San Diego Society of Natural History indemnifying its directors against and holding them harmless for liability to its licensees and invitees for property damages and personal injuries resulting solely from structural failure of building caused by an earthquake, under the terms and conditions set forth in the First Amendment to Agreement on file in the office of the City Clerk as Document No. R-251343.
