

WHEREAS, on December 4, 1979, the City Council authorized the City Attorney to settle Parcel 3 of the condemnation action entitled "The City versus Lloyd L. Cottingham, et al"; and

WHEREAS, funds in the amount of \$4,392.27 are needed to reimburse the Property Department Revolving Fund for expenses paid in connection with the condemnation of that parcel, which expenses include a small portion of the condemnation deposit, and appraisal and pre-trial costs of the City's contract appraiser; NOW, THEREFORE,
