WHEREAS, the Office of Criminal Justice Planning (OCJP) may consent to review for possible funding the project submitted by The City of San Diego referred to as "Revitalization of Case Flow Procedures," on file in the office of the City Clerk as Document No. RR 251348; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:


That the City Attorney be and he is hereby authorized, for and on behalf of said City, to submit to the Office of Criminal Justice Planning the application for grant for law enforcement purposes.

BE IT FURTHER RESOLVED, that in the event OCJP consents to fund the above project, The City of San Diego agrees to accept the grant and designates the City Attorney to execute, for and on behalf of said City, the contract for the grant for law enforcement purposes, including any extensions or amendments thereof, that do not require any appropriation of cash match.

BE IT FURTHER RESOLVED, that the City Attorney is authorized without further Council action to go to bid (when necessary) and to execute contracts for consultant services, lease/rental services, equipment purchases, and all other related contracts and agreements specified in the grant contract (including any extension or amendment thereof).

BE IT FURTHER RESOLVED, that the City Attorney, acting through the Personnel Department, is authorized to hire appropriate persons in limited positions for purposes of fulfilling the grant contract.
