

RESOLUTION NO. R-251349

(R. 80-1583)

WHEREAS, the Attorney General of the State of California has proposed the establishment of a joint law enforcement task force to operate a southbound border checkpoint at the San Diego/Tijuana border for the purpose of stemming the flow of stolen property, including stolen vehicles from the United States to Mexico; and

WHEREAS, the Attorney General has proposed that said task force and checkpoint be totally funded by monies made available for such purpose through the State of California; and

WHEREAS, it is proposed that said task force and checkpoint would be operative for a period of one year on a trial basis to determine the property recovery, crime prevention and criminal apprehension benefits thereof; and

WHEREAS, said benefits would accrue, in part, to the citizens of the city of San Diego; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego that this Council supports and urges implementation of the concept of a joint task force and southbound border check station at the San Diego/Tijuana border as proposed by the Attorney General of the State of California.
