

RESOLUTION NO. R-251350

WHEREAS, the Comprehensive Planning Organization (CPO) has prepared a Lower Income Household Allocation intended to satisfy the requirements of the California Housing and Community Development Department Housing Element Guidelines; and

WHEREAS, once approved by local agencies and the CPO Board of Directors, the allocation will be used as a basis for revision of local agency Housing Elements; and

WHEREAS, City staff recommends that certain revisions to the formulae utilized in calculating the Lower Income Household Allocation be made based on the belief that the formulae needlessly perpetuate existing inequitable distributions of lower income households; and

WHEREAS, CPO has also prepared a Regional Housing Allocation Formula to assist local agencies in developing housing programs allocating resources to provide new lower income affordable housing units; and

WHEREAS, City staff recommends that this formula be approved for the described use; and

WHEREAS, the above information and recommendations were presented to the Rules Committee by the Planning Director in a report dated February 20, 1980; and

WHEREAS, the Rules Committee approved said recommendations and forwarded them to the Council recommending approval; NOW, THEREFORE,
