WHEREAS, W/C JOINT VENTURE, a partnership, Owner, and SOUTHWESTERN CABLE T.V., a Colorado corporation, hereafter referred to as "Permittee", filed an application for permission, under Conditional Use Permit No. 589-PC, to construct and operate a T.V. office and studio facility of 22,250 square feet with parking and landscaping on a 2.7 acre site in the M-lB Zone. All of the following facts exist with respect to Conditional Use Permit No. 589-PC:

1. The proposed use will not adversely affect the neighborhood, the general plan or the community plan, and would not be detrimental to the health, safety and general welfare of persons residing or working in the area.

The location and condition of operation for this facility would tend to mitigate any adverse effect associated with this use.

2. The proposed use will comply with all relevant regulations in the Municipal Code.

The above findings are supported by the minutes, maps and exhibits, all of which are herein incorporated by reference.

BE IT FURTHER RESOLVED, that this Council does hereby cannot to W/C JOINT VENTURE, a partnership, and SOUTHWESTERN CABLE T.V., a Colorado corporation, Owner and Permittee, Conditional Use Permit No. 589-PC, in the form and with the terms and conditions as set forth in the permit attached hereto and made a part hereof.
