

RESOLUTION NO. RC-251385 (R.80-1571)

WHEREAS, Section 1930 of the Streets and Highways Code provides a procedure for the summary vacation of streets by City Council resolution where that portion to be vacated has been superseded by relocation; and

WHEREAS, those portions of Road surveys 190 and 758 have been relocated by the approval on this date of the dedication of a revised alignment for CARMEL VALLEY ROAD; and

WHEREAS, those properties adjoining those portions of Road surveys 190 and 758 to be vacated will continue to have access or will be accessible by the street which has been dedicated with approval on this date; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That portions of Road survey 190 and 758, as more particularly shown on Drawing No. 17952-D on file in the office of the City Clerk as Document No. RC-251385, which is by this reference incorporated herein and made a part hereof, be, and the same is hereby ordered vacated.

2. That the City Clerk shall cause a certified copy of this resolution, with drawing, attested by him under seal, to be recorded in the office of the County Recorder.

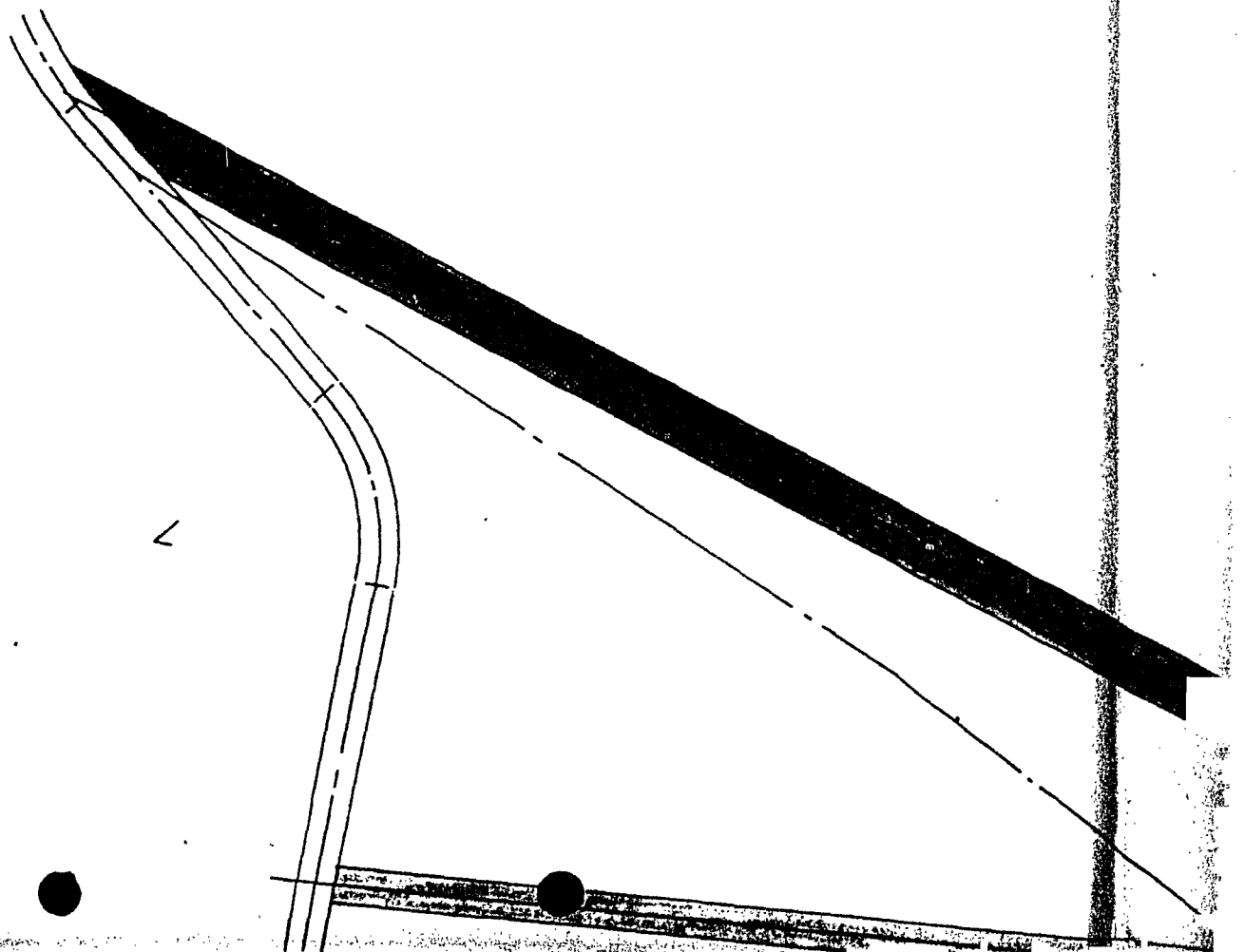

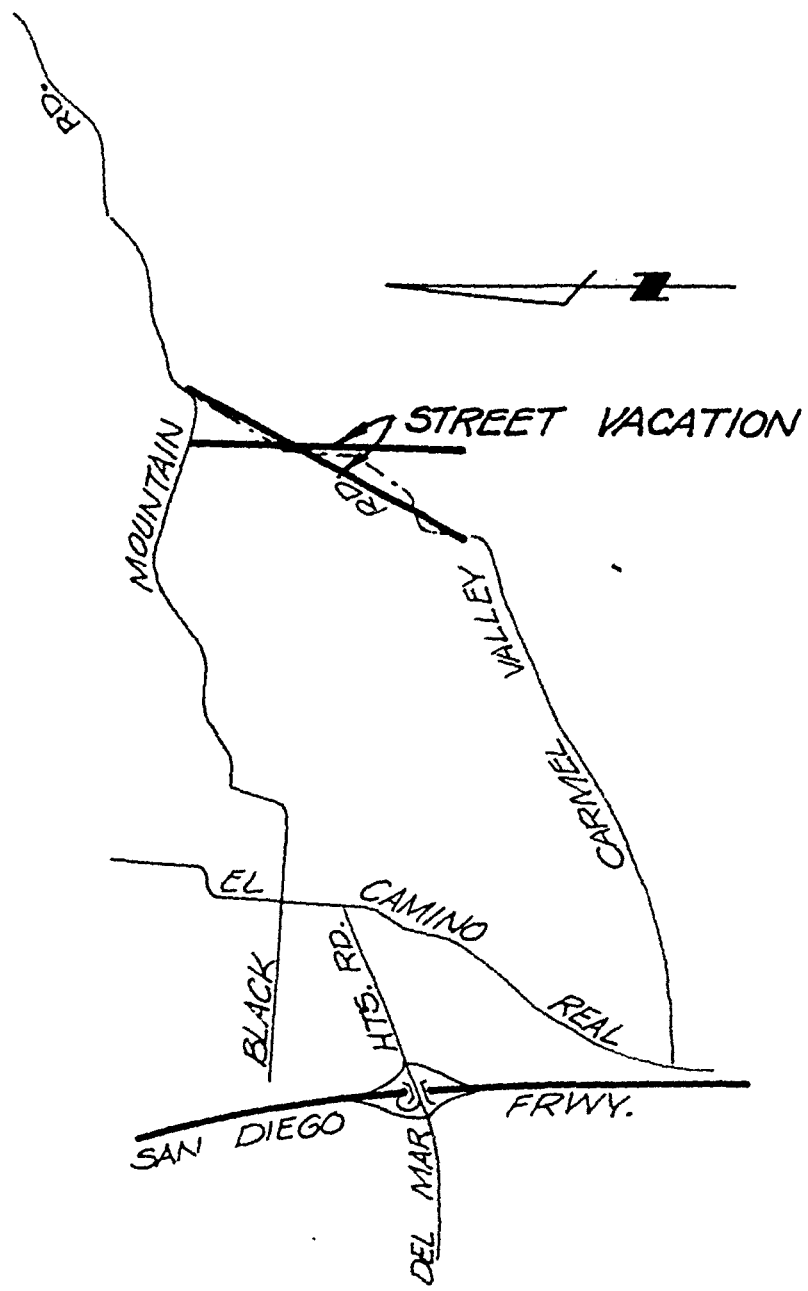

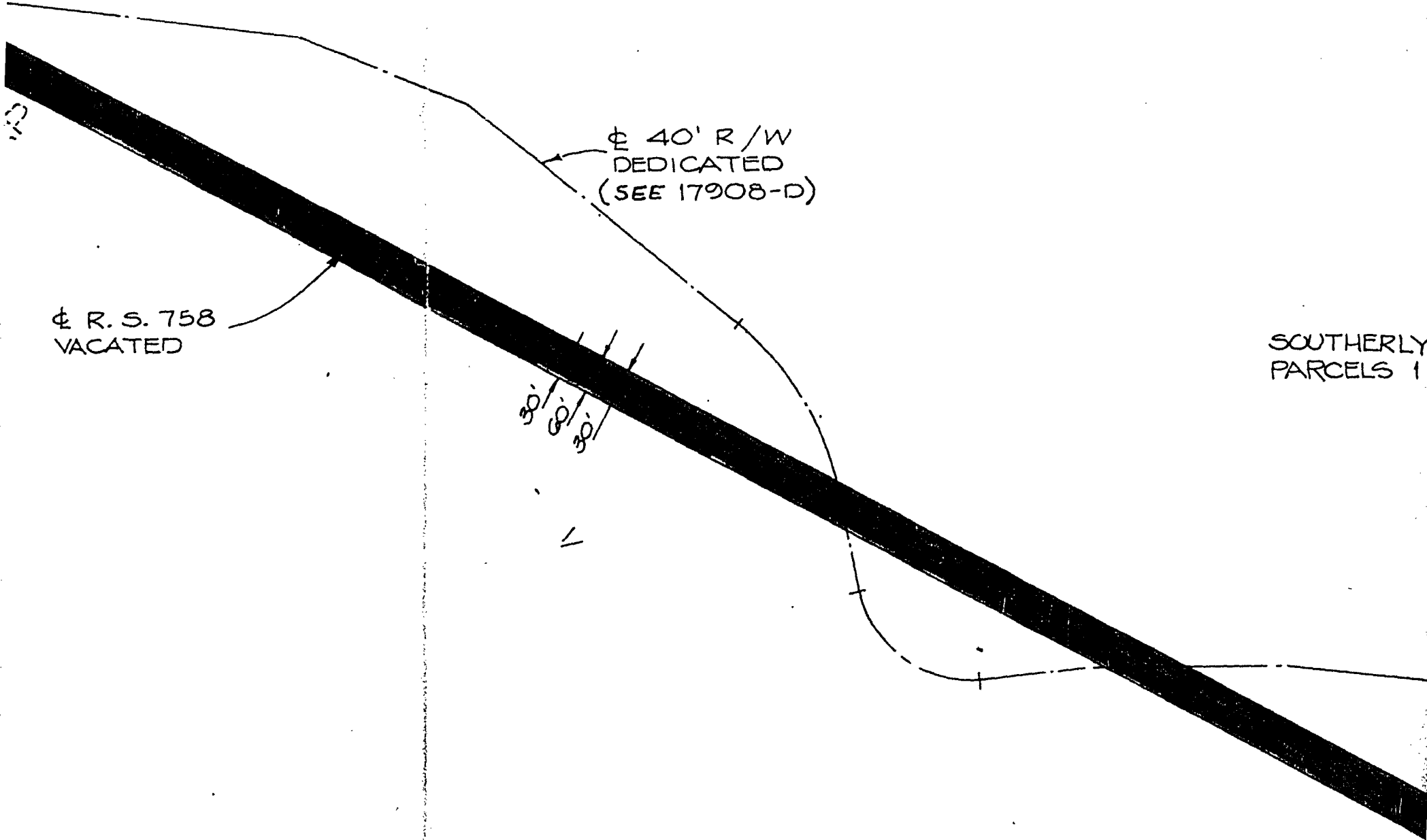
