That the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with the SOCIAL ADVOCATES FOR YOUTH, INC., to provide funds for moving expenses and a portion of the rent for a consolidated facility to serve the youth of Tierrasanta and Murphy Canyon, under the terms and conditions set forth in the agreement on file in the office of the City Clerk as Document No. RC-251389.

BE IT FURTHER RESOLVED, that the expenditure in an amount not to exceed \$18,260 from Revenue Sharing social service funds is hereby authorized solely and exclusively for the above purpose.
