VACATION OF A PORTION OF CURTIS STREET ADJACENT TO
LOT 66, OF POINT LOMA VILLAS, MAP 1587

WHEREAS, it is proposed that a portion of Curtis Street adjacent to Lot 66, of Point Loma Villas, Map 1587 be vacated; and

WHEREAS, there is no present or prospective use for the street either for the public street system for which the right-of-way was originally acquired or for any other public use of a like nature that can be anticipated; and

WHEREAS, the public will benefit from the vacation through improved utilization of land; and

WHEREAS, the vacation or abandonment is not inconsistent with the General Plan or an approved Community Plan; and

WHEREAS, the public street system for which the right-of-way was originally acquired will not be detrimentally affected by this vacation; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, California, that a portion of Curtis Street adjacent to Lot 66, of Point Loma Villas, Map 1587, as more particularly referred to in Resolution of Intention No. R- 251208, is unnecessary for present or prospective public street purposes.

BE IT FURTHER RESOLVED, that a portion of Curtis Street adjacent to Lot 66, of Point Loma Villas, Map 1587, as more particularly shown on Drawing No. 14883-B on file in the office of the City Clerk as Document No. RC- 251208,

which said Drawing is attached hereto and made a part hereof,
be, and the same is hereby ordered vacated.

BE IT FURTHER RESOLVED, that the City Clerk shall cause
a certified copy of this resolution, attested by him under
seal, to be recorded in the office of the County Recorder.

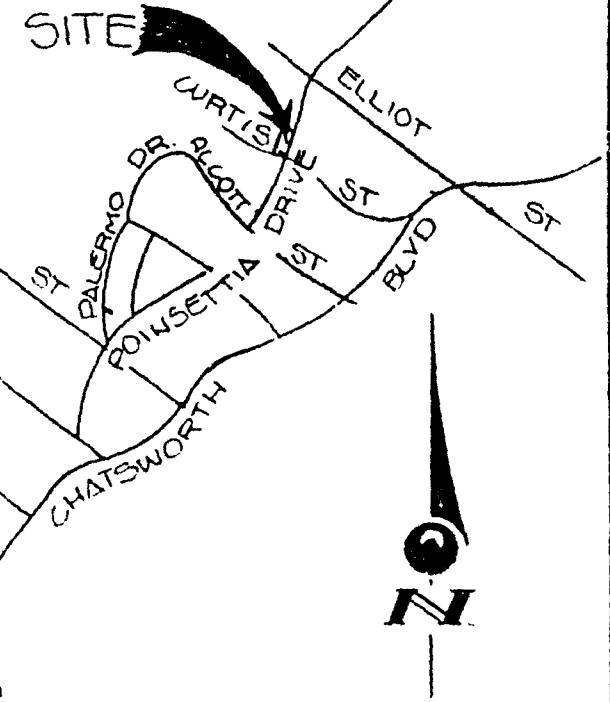
