

RESOLUTION NO. R-251437 (R.80.1292)

VACATION OF THE EASTERLY 10 FEET OF UNION STREET,
BETWEEN REDWOOD STREET AND SPRUCE STREET, ADJACENT
TO BLOCK 124, MAP 4134R. MAR 24 1980

WHEREAS, it is proposed that the easterly 10 feet of Union Street, between Redwood Street and Spruce Street, adjacent to Block 124, Map 4134R be vacated; and

WHEREAS, there is no present or prospective use for the street either for the public street system for which the right-of-way was originally acquired or for any other public use of a like nature that can be anticipated; and

WHEREAS, the public will benefit from the vacation through improved utilization of land; and

WHEREAS, the vacation or abandonment is not inconsistent with the General Plan or an approved Community Plan; and

WHEREAS, the public street system for which the right-of-way was originally acquired will not be detrimentally affected by this vacation; NOW, THEREFORE,


BE IT RESOLVED, by the Council of The City of San Diego, California, that the easterly 10 feet of Union Street, between Redwood Street and Spruce Street, adjacent to Block 124, Map 4134R, as more particularly referred to in Resolution of Intention No. R-251211, is unnecessary for present or prospective public street purposes.

BE IT FURTHER RESOLVED, that the easterly 10 feet of Union Street, between Redwood Street and Spruce Street, adjacent to Block 124, Map 4134R, as more particularly shown

on Drawing No. 14868-B on file in the office of the City Clerk as Document No. CC-251211, which said Drawing is attached hereto and made a part hereof, be, and the same is hereby ordered vacated.

BE IT FURTHER RESOLVED, that the City Clerk shall cause a certified copy of this resolution, attested by him under seal, to be recorded in the office of the County Recorder.

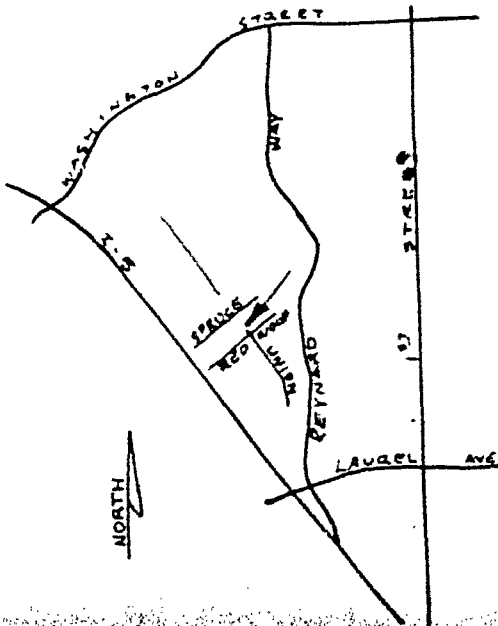

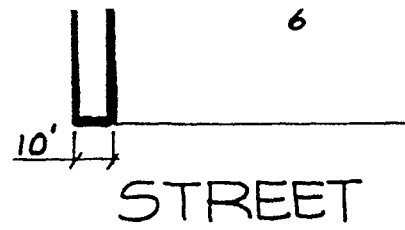
