

RESOLUTION OF INTENTION NO. R- 251438 (R.80-1588)

A RESOLUTION ELECTING TO PROCEED UNDER THE PROVISIONS OF THE STREET VACATION ACT OF 1941, DECLARING THE INTENTION OF THE CITY COUNCIL TO VACATE PROSPECT STREET ADJACENT TO LOT 34, BLOCK 59, OF LA JOLLA PARK, MAP 352, AND THE WESTERLY RIGHT-OF-WAY OF CAVE STREET AND FIXING A TIME AND PLACE FOR HEARING THEREOF

BE IT RESOLVED, by the Council of The City of San Diego, that the public interest and convenience of said City require the vacation of a portion of the streets hereinafter mentioned; and in connection therewith require the reservation of certain easements for Prospect Street adjacent to Lot 34, Block 59, of La Jolla Park, Map 352, and the westerly right-of-way of Cave Street in the area covered by such streets.


BE IT FURTHER ~~RESOLVED~~, that it is the intention of said Council to order the vacation of Prospect Street adjacent to Lot 34, Block 59, of La Jolla Park, Map 352, and the westerly right-of-way of Cave Street, as more particularly shown on Drawing No. 14882-B on file in the office of the City Clerk as Document No. RR- 251438.

The Council hereby elects to proceed, in making said vacation, under the provisions of the "Street Vacation Act of 1941".

The Council hereby fixes 2:00 p.m. April 28, 1980 in the Council Chambers on the twelfth floor of the City Administration Building, Charles C. Dail Concourse, 202 "C" Street, in said City of San Diego, as the time and place for hearing all persons interested in or objecting to the proposed vacation.

That The Daily Transcript, a daily newspaper published and circulated, and of general circulation, in the said City of San Diego, be, and it is hereby designated as the newspaper in which the Street Superintendent of said City shall cause to be published, in the manner and form required by law, notice of the passage of this Resolution of Intention, and the Street Superintendent is hereby directed to cause notices of the passage of this resolution to be posted in the manner and form required by law and to cause a notice similar in substance to be published in said newspaper in the manner required by law.
